3. How We Use Your Data

We use collected data to:

- Provide data integration services and automate data ingestion.
- Build and maintain custom Power BI dashboards.
- Deliver insights for performance monitoring and athlete development.
- Improve and optimise our services.
- · Comply with legal and regulatory obligations.

4. Legal Basis for Processing

We process data under the following lawful bases:

- Contractual necessity: To deliver the services agreed upon.
- Legitimate interest: To improve and secure our services.
- Consent: Where required, e.g. for sharing anonymised performance benchmarks.

5. Data Storage & Security

- All client and athlete data is stored securely within **Azure cloud infrastructure**.
- API keys and secrets are stored using Azure Key Vault with restricted access.
- Access is strictly limited to authorised Applied Performance team members.
- We implement regular security checks and monitoring.

6. Data Sharing

We do **not** sell or share personal data with third parties for marketing purposes. Data may be shared:

- With contracted service providers (e.g. Microsoft Azure, Power BI).
- Where legally required, or to comply with regulatory obligations.

7. Data Retention

- Data is retained only for as long as required to provide services.
- On client request, all associated data can be securely deleted from our systems.
